



## **OCTA Environmental Mitigation Program Hike Sweepstakes Official Rules**

By participating in this promotion, you agree to the **Official Rules**

### **NO PURCHASE OR PAYMENT NECESSARY TO WIN**

**Eligibility:** All eligible hike participants ages 18 or older attending the March 16, 2024 hike will be entered into a raffle. OCTA employees, sponsors, vendors, agents and their immediate family members are not eligible.

**Timing:** The raffle will take place on March 16, 2024, and one (1) winner will be selected at the conclusion of the hike.

**How to Enter:** Register for the March 16, 2024 OCTA hike at [www.preservingourlegacy.org](http://www.preservingourlegacy.org). Participants can also show up the day of the event without registering. All participating hikers 18 or older will receive one (1) raffle ticket for a chance to win a gift card.

**Limit:** One raffle ticket per person. The first ticket received will be entered into the Sweepstakes. Any subsequent entries received from the same person will not be counted.

**Drawings:** OCTA will randomly select the potential winner from all eligible Sweepstakes entries. One (1) winner will be randomly selected and handed the gift card at the conclusion of the hike. If the designated winner does not claim the prize, another winner will be randomly selected.

**Prizes:** Limit of one (1) prize per person. Each winner will receive one (1) REI gift card with a value of \$75. Prizes are distributed at OCTA's discretion and can be substituted at any time.

Prizes must be accepted as awarded, may not be substituted, and have no cash value. Exchanges or replacements will not be made if a prize is lost, stolen, or damaged.
